- an excerpt from the trade register or the chamber of commerce or any similar agency with respect to the Participant;
- the most recent articles of association of the Participant
- copies of the valid passports of the legal representative and the Authorised Users; and
- a copy of the signed Participation Agreement CASS.

In addition to the abovementioned documents, Climex is - at its sole discretion - entitled to request additional information from the Participant, in order to verify whether the Participant fulfils all requirements for access to the Climex Trading Platform or such information Climex reasonably deems to be fit.

The Climex General Terms and Conditions, the Climex Trading Rules and the Climex Rulebook form part of this Climex Participation Contract. The Participant acknowledges that it has received those documents, as well as the Climex user's guide. Capitalised terms are defined in the Climex Definitions.
